RE: RoHS3

To Whom It May Concern:

Regarding the information requested concerning Unified Wire and Cable products:

Unified Wire understands the "Restriction of Hazardous Substances" Directive, citation 2002/95/EC and 2003/11/EC, 2011/65/EU and EU 2015/863 commonly known as RoHS3. This Directive restricts the use of 10 specific substances in electrical and electronic equipment sold in the EU beginning in 2019.

These restricted substances are:

1. Lead
2. Mercury
3. Cadmium
4. Chromium VI
5. Polybrominated biphenyls (PBB)
6. Polybrominated diphenyl ethers (PBDE)
7. Bis(2-Ethylhexyl)phthalate (DEHP)
8. Benzyl butyl phthalate (BBP)
9. Dibutyl phthalate (DBP)
10. Diisobutyl phthalate (DIBP)

Additionally, under the proposed RoHS 3, more substances may be restricted if they pose an unacceptable risk. They would be reviewed by the Registration, Evaluation, Authorization-and restriction of- Chemicals (REACH) methodology and additional substances are listed that will be assessed as a priority.

Accordingly, Unified Wire does not intentionally add these substances to any of our product. As you may know, products made with antimony dioxide, and copper, may contain trace amounts of lead impurities.

Therefore, as of this date, the product we supply is in compliance to the RoHS3 EU 2015/863 directive.

The PVC compound used in some products does contain antimony dioxide, which is a California Proposition 65 chemical. Keep in mind that all of our PVC based compounds are produced with polyvinyl chloride resin that may contain trace levels, < 0.001% by weight of vinyl chloride monomer, which is also a listed California Proposition 65 chemical. Compound Supplier MSDS available upon request.

The product does contain copper however does NOT contain any Metals of Conflict Sources, Beryllium, Nickel or Nickel based materials Red Phosphorous, Latex, Melamine, Bisphenol A (BPA), Perfluoro-octane Sulfonates (PFOS), Polycyclic Aromatic Hydrocarbons (PAHs), Chlorinated Solvents, Dimethyl Fumarate (DMF), PCBs or Asbestos compounded into the products.
